The following instructions may please be noted carefully before filling up the nominations:

1. The candidate must affix Self-attested recent photo on the nomination form.
2. The candidate must have completed 10 years of life membership of ISTE as on 30th June, 2026 for the post of National Executive Council & Section Chairman.
3. There will be one post each of the Section Chairman in the notified 19 Sections.
4. Proposer and Seconder should be life member of ISTE from the same ISTE Section from where the Candidate is contesting.
5. Each nomination form filled by candidate must have different proposers and seconders.
6. Women candidates applying for the post of EC/SC/SMC through both Women Reserved (WR) & Un Reserved (UR) categories must fill separate nominations forms. Proposer & Seconder must be different for different applications & shall have to pay separate nomination fees for each nomination she files.
7. Ensure Name, address with Pin code & Life Membership (LM) No. of candidate /proposer/ seconder are correct & Email/Phone should be correctly mentioned as per registered with ISTE.
8. While filling up the nomination, Name of the Candidate should be mentioned legibly in Capital Letters and is as per registered with ISTE.
9. Nomination fees prescribed for nomination must be paid in the form of DD drawn in favour of ISTE General A/c payable at New Delhi or NEFT/RTGS/IMPS. Each nomination must be accompanied with separate DD/ NEFT/RTGS/IMPS with Transaction ID details.
